The Kinship Living Program provides direct support to 30 foster youth between the ages of 14-17 that have been separated from their biological parents and live with extended family members like grandparents, aunts and uncles or older siblings.

The program serves a dual purpose in that it provides for items such as school supplies, backpacks, shoes, clothing and other essential items in a format that supports financial literacy and responsibility in managing an assigned monthly budget and promotes self reliance for future independent living skills. Each qualified participant must log onto the Amazon site into a specific account set up in their name and choose items that they feel will be of value to them. They have a limited list of items to choose from that fall into specific categories of school supplies and shoes and apparel.

Dear Applicant:

## Villa Park Rotary Club District Grant Process

### 1. A Detailed Project Description

The Kinship Living Program seeks to offer adolescents aged 14 to 17, who are placed in relative care due to safety concerns or potential abuse by their parents, opportunities to make personal choices that enhance their happiness and contribute to their self-esteem and self-acceptance.

- a. The funds will be used to support the program which aims to alleviate financial burdens for caregivers associated with purchasing school supplies, back packs, shoes, clothing and other essential items.
- b. The program is direct support for foster youth in our local community
- c. The timeline is September 1<sup>st</sup>, through November 30<sup>th</sup> 2025.
- d. Members of the VPRC are involved in the oversight of the program and selection of the qualifying youth and the items they request.

### 2. Budget Breakdown

- a. Total Project cost for the Fall Semester is \$4,500.00

- c. In the Orange County area there are approximately 3,000 foster youths in out-of-home care. In many cases this does not include youth who are living with extended family members. This sector is known as Kinship Care. Some of these youths do not receive benefits through the County and the caretakers lack the resources to provide many of the basic needs for the youth they care for. The Kinship Living Program was developed to assist in providing these resources.
